## 3. Technical Officials

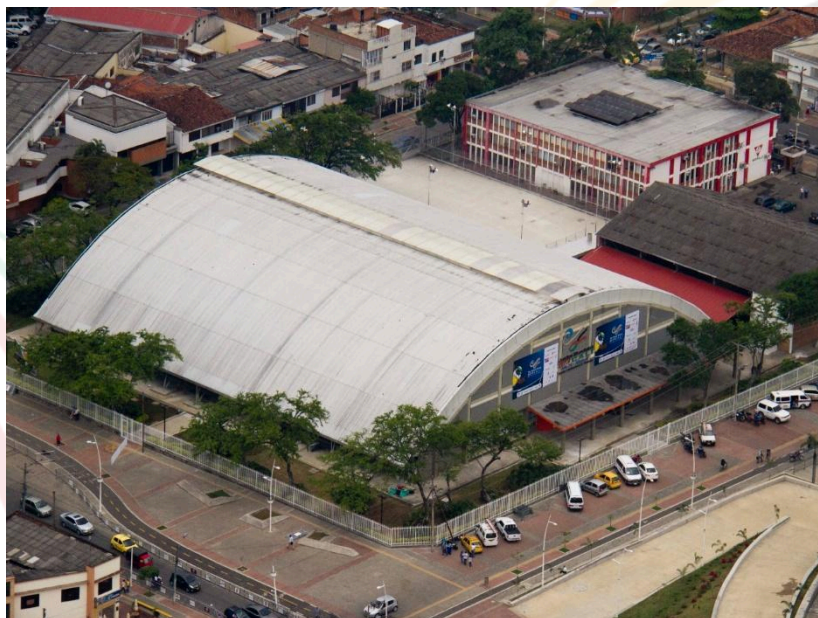
- 3.1. In the 2024 FISU AMÉRICA Games, all technical officials will be from Colombia.

## 6. Services at the Competition Venue

- 6.1. **Changing Rooms:** Available for athletes and coaches, separated by category.
- 6.2. **Hydration:** Provided at the competition venue for athletes and coaches.
- 6.3. **Medical Services:** During the competition, medical services such as trauma doctors, physiotherapists, paramedics, and a medical ambulance will be available.
- 6.4. **Ball:** Female: B6G4500 - Male: B7G4500

## 7. Procedures Before, During, and After the Competition

### 7.1. Development of the Competitions:

- 7.1.1. Athletes must identify themselves with the official event accreditation provided by the Organizing Committee.
- 7.1.2. In case of lost accreditation, a fee of 10 USD must be paid, and prior documentation presented.
- 7.1.3. The Organizing Committee, in coordination with national sports federations and sport-specific coordinators, will confirm results and any incidents.

## 8. Appeals

The stages for submitting an appeal are as follows:



- 8.1. **1st instance:** Competition jury (tribunal)
- 8.2. **2nd instance:** Technical commission of the Games
- 8.3. **3rd and final instance:** Executive Committee

## 9. Requirements for Appeals:

- 9.1. Appeals must be submitted to the competition jury of each sport after the event in question ends. The discipline delegate or head of delegation is the only authorized person to sign the written appeal within an hour after the competition. The written appeal should include:
  - 9.1.1. Event details (individual sports), location, date, and time.
  - 9.1.2. The type of rule violation, mentioning specific articles or sections infringed.
  - 9.1.3. Description of the request.
  - 9.1.4. A fee of 65 USD must be paid with an appropriate receipt. If the appeal is lost, the fee is retained by the Organizing Committee.
  - 9.1.5. Only regulatory and disciplinary rulings can be appealed; technical officials' decisions cannot be appealed.

## 11. Medals

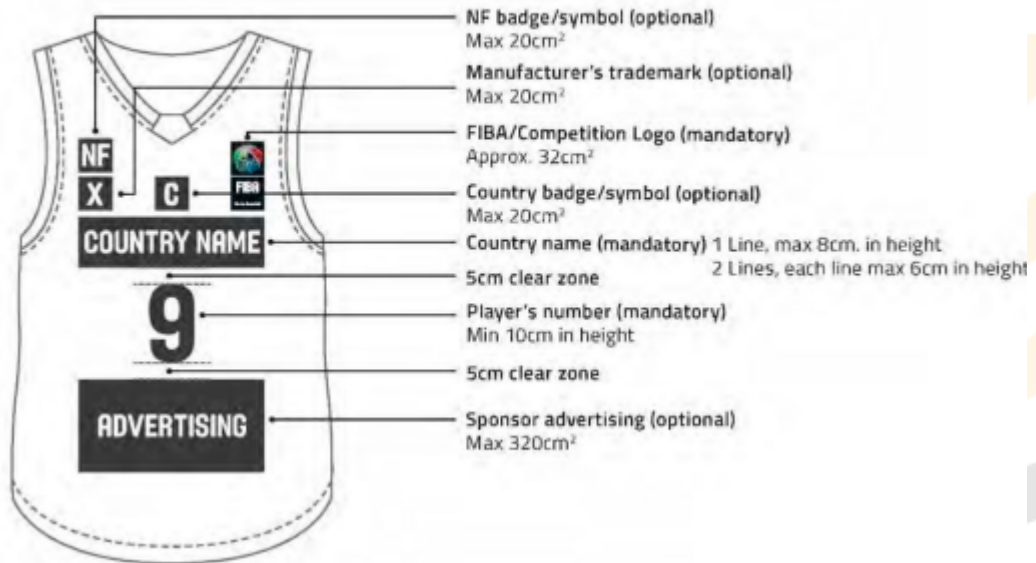
The Organizing Committee will award individual medals as follows:

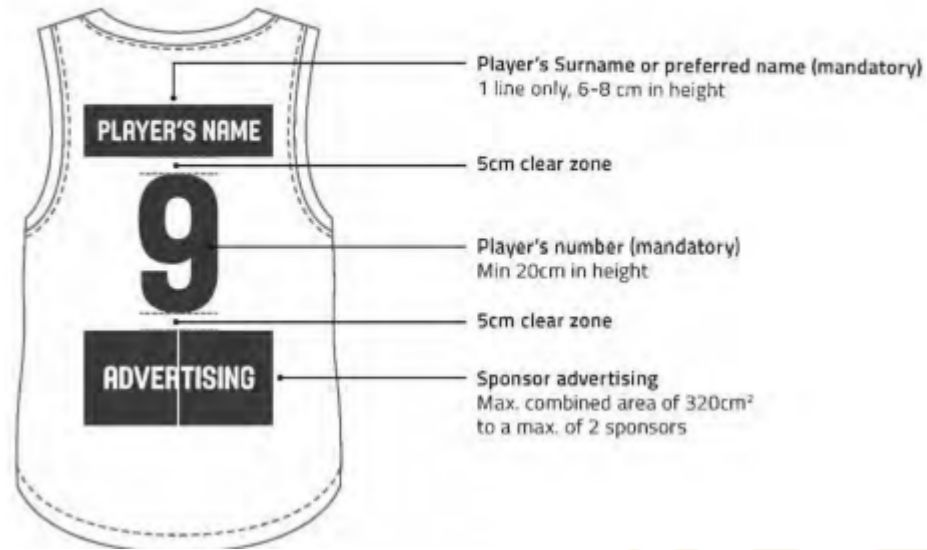




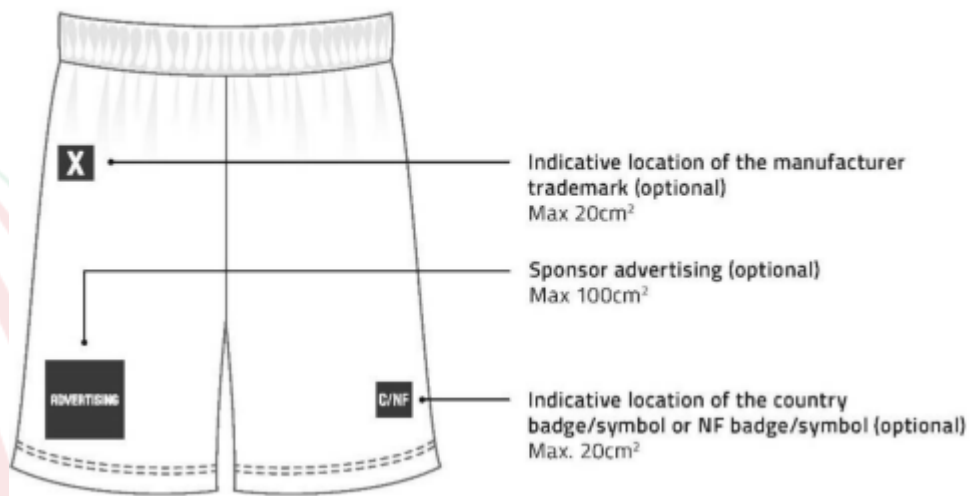
